**Horse Owner and or Roper Agrees:** That s/he has a current Health Certificate, negative coggins test, and brand inspection if required from h/her state.

**Insurance of Horse(s) in Transit:** Horse Owner understands and acknowledges that insurance is not provided to the Horse Owner by WSTR or the South Point Hotel and Equestrian Center. If the Horse Owner elects not to secure insurance, then s/he agrees that s/he assumes all risks, expenses or liabilities associated with stalling his/h horse and the transport, care, loading and unloading his/h horse(s) by Cruz Bay Publishing, Inc., dba WSTR and/or South Point Hotel and Casino Equestrian Center associates.

**“Hard Loader” “Unruly Staller”:** Difficult loaders will not be transported. Unruly horses will be asked to leave the premises and will not be hauled nor will be refunded any stall fees.

**Damage to Trailer or Stall Equipment** caused by your horse will be your responsibility and you agree to pay for the actual cost of repair.

**Release of Liability:** Horse Owner and Horse Rider (if different) hereby voluntarily releases and forever discharges Gaughan South LLC dba South Point Hotel and Casino and associated facilities, Cruz Bay Publishing, Inc., dba World Series of Team Roping, its sponsors, its agents, servants, employees, and representatives, and associated vehicle dealership(s), associated Trailer Sales companies and or dealership(s), and the Transporter or Barn workers from any and all liabilities, claims, demands, actions, or rights of action, which are related to, rise out of, or are in any way connected with the transport and/or stalling of the horse owner’s horse(s).
