With 4,500 ropers attending, stalls are limited, therefore only one stall per roper, two if heading and heeling. The South Point Indoor Stalls are underneath the arenas. The South Point Centex Lot is next to the Outdoor Qualification Arena. Indoor stalls will have access to a tack stall. INDOOR stall price includes the use of a Tack Stall assigned by WSTR. Under no circumstances can a roper use the provided tack stall as a horse stall. Outdoor stalls will have access to their trailers and ropers can easily ride to the arenas.

Stalls are sold for the week with advanced reservations, regardless of how many days you plan to attend. This allows ropers to change their travel arrangements without affecting their stall availability.

**No stall refunds after the draw is posted in November.** Early departures are not eligible for a partial refund.

Priority on stall assignments is based on how many times you are entered and your hotel reservation. Even if you select an indoor stall in January, you may not get the indoor stall if you are only entered once and/or you are not staying at the South Point. Stall assignments are confirmed in November.

Because we have different stall locations it is important to let us know who you are traveling with so that we can attempt to get each of you at the same location. (view the stall site map at WSTRoping.com under the forms tab).

As a Participant or Horse Owner who is lending or renting a horse to a Participant I have read and voluntarily agree that, at my option, I am renting a horse stall to participate in the WSTR Finale Event at its associated stalling locations.

- Horse Owner and/or Roper Agrees: That s/he has a current Health Certificate, negative coggins test, and brand inspection if required from his/her state.
- Horse Owner agrees that she/he assumes all risks, expenses or liabilities associated with stalling his/her horse and the transport, care, loading and unloading his/her horse(s) while in attendance of and on any properties associated with the WSTR Finale.
- Damage to any property at any of the associated properties connected to the WSTR Finale caused by his/her horse will be his/her responsibility and he/she agrees to pay for the actual cost of damage.

**Release of Liability:** Horse Owner and Horse Rider (if different) hereby voluntarily releases and forever discharges Gaughan South LLC dba South Point Hotel and Casino and Equestrian Center and associated facilities, Equine Network LLC, dba World Series of Team Roping, its sponsors, its agents, servants, employees, and representatives, workers and volunteers from any and all liabilities, claims, demands, actions, or rights of action, which are related to, rise out of, or are in any way connected with the stalling of his/her horse whether owned or borrowed. Horse Owner further agrees, promises and covenants not to sue, assert or otherwise maintain or assert any claims against its agents or employees, for any injury, death, disease, or damage to the aforementioned horse(s) arising from or in connection with the said horse(s) or from any claims asserted by other third parties regardless of who is at fault.

**Entire Agreement:** Horse Owner and Horse Rider (if different) understands that this is the entire agreement between Horse Owner and Horse Rider (if different), Equine Network LLC, dba WSTR, Gaughan South LLC dba South Point Hotel and Casino and Equestrian Center its agents or employees, and the stall manufacturer/facility and transporter and it supersedes and cannot be modified or changed in any way by the representations or statements of any agent or representative of WSTR except its President or Vice President.
